How we store your personal information

We keep your name and contact details for 12 months. We will then dispose of your information by permanently deleting electronic data held and shredding any paper copies held.

Your data protection rights

Under data protection law, you have rights including:

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.
